PREVIOUS ACTION:

On January 29th, 2008, the Policy Committee approved the revision of the MTP. The primary purpose of the revision was to bring the document into compliance with the requirements as stipulated by the Safe, Accountable, Flexible, and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) of 2005. The document has since been revised in November, 2008.

BACKGROUND:

The Laredo Metropolitan Transportation Plan is an official, comprehensive, intermodal transportation plan developed and adopted for the metropolitan planning area. The MTP identifies the existing and future transportation needs and develops coordinated strategies to provide the necessary transportation facilities essential for the continued mobility and economic vitality of Laredo. These coordinated transportation strategies include roadway development and operations, truck and rail freight movement, transit operations, bikeways and pedestrian facilities. The development of the MTP is required under the Transportation Equity Act for the 21st Century (TEA-21), and the Safe, Accountable, Flexible, and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) of 2005 to assure the continuation of federal transportation funds. The plan must address, at a minimum, a continuous twenty-year planning horizon.

As of December 11, 2007, SAFETEA-LU requires that all revisions to the Transportation Improvement Program (TIP), shall also be reflected in the Metropolitan Transportation Plan (MTP). As the TIP is being proposed for revision, so to the MTP is also recommended for revision.

The primary purpose of this MTP revision is to include all those revisions being proposed for the February 2009 TIP revision.

The Technical Committee met on December 8, 2008 and recommended <u>approval</u> of initiating a 30-day public review and comment period for the proposed 2005-2030 Laredo Metropolitan Transportation Plan.
