CM. Galo expressed his concerns regarding the creation of an Active Transportation Plan sub-committee. He stated that he was okay with having the sub-committee if it was empowered to give recommendations only.

Judge Tijerina stated he agreed with CM. Galo.

Dr. Martinez expressed full support for the Active Transportation Plan sub-committee.

David Salazar, TxDOT District Engineer, stated that it also seemed that the sub-committee would mostly be focusing on bicycle paths.

Mr. Snideman stated the sub-committee would provide recommendations on other modes of alternative transportations including safe routes to school, transit, and micro mobility.

By consensus, the MPO committee initiated a 10-day public review and comment period, for the proposed amendment(s) of the MPO By-laws.

D. Discussion with possible action to cancel or reschedule the December 21st, 2020, Policy Committee meeting.

Mr. Snideman informed the committee that the item was placed on the agenda because in previous years, there was usually no quorum due to the meeting date being held on the week of the Christmas holidays. He informed the MPO committee that if there was a crucial item that needed to be placed on the agenda, a special meeting could be scheduled.

- 2. Los Presidentes (Cuatro Vientos to Concord Hills) City of Laredo One Stop Shop review of Los Presidentes comments completed. ROW Plats were submitted in the week of the 9th of November. Advertisement is forecasted for mid-December 2020.
- 3. Vallecillo Road –Traffic study was ongoing. Scheduled completion was December 2020.
- 4. WCCL RMA Board meeting is projected for the last week of November 2020.
